  - **b.** Membership Update. Current membership of 3,667 with a forecast of 3,620 for 2025-2026

- 7. Financial Report
  - a. As of April 11, 2025, there is 25.08 months of cash-on-hand. Estimation of cash on hand in August 2025 will be about 14.20 months.
  - b. Total cash in the bank is currently \$7,913,759, including Principal Leadership cash. The Principal Leadership balance is \$2,407,826 as of April 11, 2025.
  - c. AWSP total revenue as of May 31, 2025, was \$776,592, with total expenses of \$663,796 for a net income of \$112,796.
  - d. Stephanie Teel moved, and Cameron Grow seconded a motion to increase the 2025/26 Membership dues rate with a \$15 increase, for a total rate of \$952 per Active Member using an estimated number of active members of 3,620 and this value of \$2,479,700 will be used for the 2026 AWSP budget. Motion passed.
- 8. IPP and Next Level Leader Update Ashley Barker, Coordinator
  - a. Next Level Leaders is for leaders who: Have 3+ years in building/district educational leadership, are members of AWSP or WASA, have school district teams who want to participate, represent each ESD region. Applications are available now.
  - b. The IPP project focuses on building the capacity of district and school leaders to implement data-driven, evidence-based inclusionary practices. Phase 1 runs from March to June 2025.At the end of Phase 1 there will be a detailed, actionable program design, along with a sustainability plan that ensures the practices can continue to grow and evolve. Not only about compliance, but it's also about leading with purpose, improving equity, and making a measurable difference for Washington's students and educators.
