AWSP Business Report

- 9. Patrick Vincent moved, and Heather Hastie-Ulery seconded a motion to approve the board minutes from September 26, 2024. Motion passed.
- 10. There are currently 3,941 members, compared to 3,903 in January 2024. A few districts have not paid their administrators' membership dues for the 2024-25 year.
- 11. AWSP has hired an attorney on retainer to assist with member legal issues.
- 12. The School Leader Collaborative currently has 12 states that are members. The first conference will be in June 2025.
- 13. The Regional PLC meetings are going well. ESD 113 had 40 members attend out of 273 members in their region. ESD 112 had 50 attendees. ESDs 189, 114, and 101 have meetings scheduled.

Financial Report

- 14. As of January 23, 2025, there is 28.36 months of cash-on-hand. Estimation of cash on hand in August 2025 will be about 12.83 months.
- 15. Total cash in the bank is currently \$7,406,577, including Principal Leadership cash. The Principal Leadership balance is \$1,492,076 as of January 23, 2025.
- 16. Board and Grade Level Leadership expenses as of December 31, 2024, are \$215,528.
- 17. AWSP total revenue as of December 2024 was \$5,279,708 with total expenses of \$4,598,418 for a net income of \$681,290.
